Parking

The Copperfield HOA Covenants (Section 15, Use of Other Structures and Parking, prohibit habitual parking on any street or public right-ofway, except during construction.

Fire Hydrants

Fire hydrants that are not visible or are hidden behind vegetation can delay the fire department's response to an emergency. A minimum 36-inch (three feet) diameter clearance shall be maintained around a fire hydrant.

Mainstream Update

Mainstream has completed the fiberoptic infrastructure installation in Copperfield. This service was approved by Floyd County and Mainstream obtained all necessary permits from the City of Georgetown to perform the work. They're now inviting Copperfield residents to sign up for service.

The above ground markers that were installed ensure Mainstream is compliant with the Indiana Utility Regulatory Commission's regulations. Any homeowner who removes the marker(s) should understand this can delay service restoration in the event of an outage.

These and other utility markers are installed for safety reasons. Remember to always call 811 before digging. One call does it all. The one-call center coordinates with member utilities to have them mark any underground utility lines in the area of the proposed digging project. Contacting 811 before digging is the law!

Please maintain your yard! It helps everyone's property values. Grass should not be taller than 6".
